

Studio founders Shoshana Treichel and Ashley Ramsay-Naile first collaborated on a reception for the 2015 Mobile Jewish Film Festival. They quickly formed a friendship as they bonded over their shared ideology of helping others embark on a personal journey of self-discovery and renewal.

THE REAL ESTATE CORNER



A new event space opening on St. Louis Street is reportedly expected to be the largest of its kind seen in Downtown Mobile, with the capacity to host Mardi Gras balls, and available for reservations towards the end of this year. Crown Hall owner Sarah Clark acquired the space to be a part of her expanding franchise and it will be named Crown on St. Louis. The former warehouse and antiques gallery has an interior footprint of some 30,000 square feet and Clark envisions accommodating between 2,500 to 3,000 occupants for occasions such as

weddings, concerts and parties when renovations are completed (with a courtyard added). In conjunction with the purchase, the City of Mobile has been working on revitalizing a 17-block section of St. Louis Street that will upgrade existing utilities, roadway, storm drainage and landscaping. More business growth to the area will also help facilitate more federal money for improvements. The city has reached 100% construction design on the project and is currently waiting for federal approvals before starting the revitalization project's bid process. Construction is expected to begin in the spring of 2025.

In December ground was broken on a \$1.7-million investment that will add a 3/4-mile segment to the Three Mile Greenway Trail as well as having renovation work done on the Mobile Japanese Garden (MJG) parking lot. Both projects will improve accessibility to parking and the trailhead at the MJG.

This segment of the trail will build out its West Mobile point and is being funded through a grant from the Alabama Department of Transportation. Improvements to the parking facilities at the MJG are being funded through the city's Capital Improvement Program. Construction is scheduled to be completed by the summer of this year. To accommodate these projects, MJG was closed to the public last month and will remain closed until this summer. The Three Mile Creek Greenway Trail is a nearly 7-mile network connecting the city along the path of Three Mile Creek. The multiphase project is a key component of the Mobile Greenway Initiative, an 18-mile system of interconnected parks, trails and street projects with assets designed for pedestrians and cyclists.

Last month D.R. Horton held a grand opening of the Hawkins Manor development located at 7400 Hawkins Manor W in West Mobile. Visitors were able to tour a model home and learn more about the site. Hawkins Manor is offering multiple floor plans in the D.R. Horton "Tradition" series, with single-story models ranging from nearly 1,600 to a little over 2,000 square-feet. Plans range from three to four bedrooms, all with two bathrooms, and a two-car garage.
