## Do you know your Chamber?

The earliest chamber of commerce in the United States was established on April 22, 1912. They named it the US Chamber of Commerce, and it still exists today. They focus on protecting the interests of American businesses. The first chamber of commerce ever created came about in 1599 in Marseille, France. Its purpose was to gather merchants, industrialists, traders, and craftsmen to discuss and tackle community challenges. The chamber of commerce was a place of unity, even among competitors. Their voice soon became a persuasive power in the community. Yet numerous smaller chambers have cropped up throughout the nation as a voice for local area businesses. 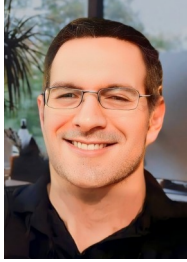

# THE REAL ESTATE CORNER



The iconic, 16-floor, cylindrically shaped Holiday Inn Downtown, located at 301 Government Street in downtown Mobile, was put up for auction recently with an asking price of \$4,700,000. “The site is in ideal proximity to the Mobile Civic Center, Mobile Carnival Museum and Mobile Convention Center. Twin Hotels LLC sold the hotel to Manhantraj Hospitality LLC for \$12,000,000 in 2022.” local publication Downtown Mobile Today said in a media release.

Wellness Realty, LLC (The Wellness Collective) paid \$375,000 last month for a 14,000-square-foot office building located at 960 Downtowner Boulevard in West Mobile. Leigh Rendfrey and Jay Roberds of CRE Mobile represented the seller in the transaction. The Wellness Collective is a mental health center for children, adolescents, adults, couples and families.

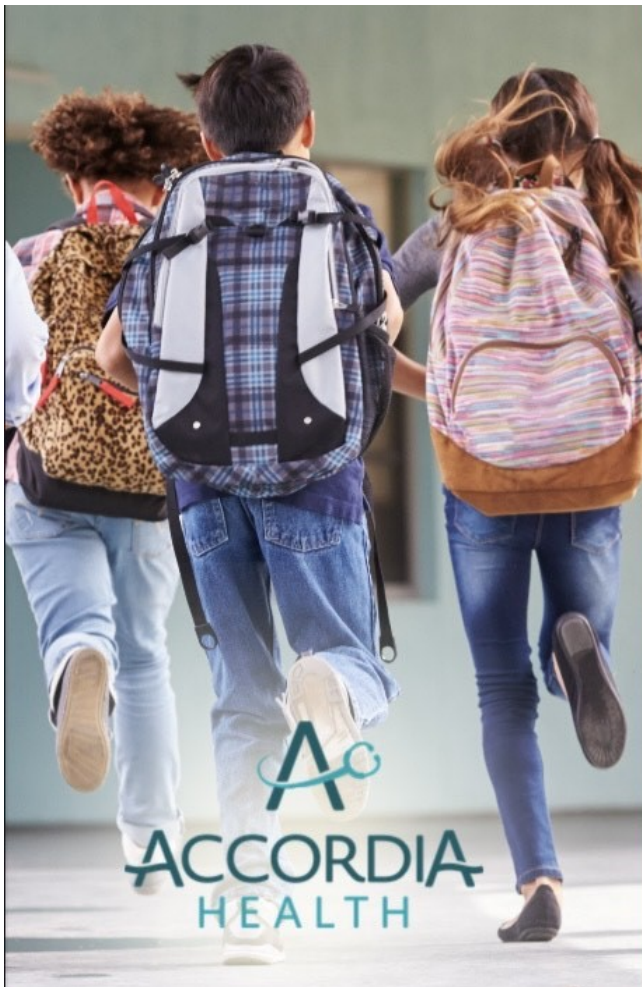
Last month Louise Doggett Antiques leased an approximately 2,200 square foot standalone building with attached parking found at 2561 Dauphin Street in Mobile. Bradford Ladd of Roberts Brothers Commercial & Property Management Inc. represented Louise Doggett Antiques in the transaction.

A local investor paid \$799,000 for some 12,030 square feet of property, holding multiple buildings and found at 10160 Airport Boulevard in West Mobile. Angie McArthur of Stirling Properties worked for the buyer in the deal. The property will continue to be leased to existing tenants.

Local investors paid \$920,000 in August for a two-story, 7,536-square-foot building located at 803 Government St. in downtown Mobile. Josh W. Hall and Pete Riehm of CRE Mobile worked for the seller of the fully leased building in the deal. Jay Roberds of CRE Mobile represented the buyers

Local medical cannabis retailer, Route 420 Dispensary, recently leased a 2,078 square foot space located at 7850 Airport Boulevard in West Mobile. Chris Harle and Leigh Dale Younce of White-Spinner Realty represented the landlord in the transaction.
