## 2018 ANNUAL CHRISTMAS PARADE

### **ANNUAL CHRISTMAS PARADE RULES**

Registration/Float check in will begin at 8:00 a.m. All Floats must be in line by 9:00 the day of the parade.

Judging for "**Best Decorated Float**" will begin at 9:00 am.

1. All Floats must submit proof of insurance & drivers license of driver
2. There will be only one Santa Claus in the parade (He is on the Fire truck)
3. Consumption of Alcoholic beverages by drivers or any participants before or during the parade is strictly prohibited.
4. Float size: No more than 12' wide and no taller than 12' tall.
5. No Mardi Gras floats, nor mask are allowed. Each float must be decorated appropriately or you may be refused entry to the parade lineup.
6. Each participant will provide their own throws
7. No horses are allowed in the parade (w/ the exception of the Sheriff's Office & Mobile Police Dept. )
8. All applications and floats are subject to approval by the SouthWest Mobile County Chamber of Commerce.
9. Children must be accompanied by an adult.
10. A participants/floats must have a waiver form completed and submitted to the SWMCCC or they will not be allowed to participate. All waivers are Due by November 20th.
11. Please make sure all floats are identified with name of organization.
12. You must be in line by 9:00 a.m. and ready to begin the parade by 9:45. Line up will begin at W.C. Griggs at Three Notch Road; Mobile, AL.
13. All trash should be picked up around your staging area before the parade begins.
14. Sharp, hard or dangerous items should not be thrown from your float.
15. Only Christmas music can be played during parade.
16. No Adult behavior, Adult themed activities or Adult throws accepted.

**We ask that on the parade route, to please not throw empty bags or debris on the street.**

**Thank you for your participation and cooperation.**

**Parade officials have the authority to remove any participant who does not abide by all rules and regulations.**
